- 1. The Madhya Bhotekoshi Jalavidyut Company Limited (MBJCL) has allocated funds for Middle Bhotekoshi Hydroelectric Project (MBKHEP) and intends to apply part of the funds to cover eligible payments under the contract for which the Invitation for Bids (IFB) is issued. Bidding is open to all eligible Nepalese Bidders.
- 2. The Bidder may bid for any or all of the packages as invited in the IFB. Bidders, bidding for more than one package will so indicate in their bid, together with a statement regarding any discounts/cross discounts offered, but the Employer may approve the bid for one or any least cost combination of contracts subject to Bidders meeting qualification. The Bidder should meet the qualification criteria separately for each bid and in aggregate as stated in the IFB.
- 3. MBJCL/MBKHEP invites sealed bids from eligible Bidders for the construction of three different packages under National Competitive Bidding procedures. Only eligible Bidders with the following key qualifications should participate in these biddings:

Three different set of Bidding Documents may be purchased from the office of Middle Bhotekoshi Hydroelectric Project (MBKHEP), Sindhupalchok by eligible Bidders on the submission of a written application separately for each package, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 5,000 (Five Thousands only) by a Bank voucher of the amount deposited in the Current Account No. 037 04578650014 of Himalayan Bank Limited in the favor of the Madhya Bhotekoshi Jalavidyut Company Limited (MBJCL) till Shrawan, 3, 2075 separately for each package.
- 6. Pre-bid meeting shall be held at the office of Middle Bhotekoshi Hydroelectric Project (MBKHEP), Barhabise Municipality-5, Khorang, Sindhupalchok at 2:00 PM on Ashadh 26, 2075.

- 7. Sealed bids must be submitted to Middle Bhotekoshi Hydroelectric Project (MBKHEP), Barhabise Municipality-5, Khorang, Sindhupalchok by hand on or before 12:00 Noon, on Shrawan 4, 2075. Bids received after this deadline will be rejected.
- 8. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on Shrawan 4, 2075 at the office of Middle Bhotekoshi Hydroelectric Project (MBKHEP), Barhabise Municipality-5, Khorang, Sindhupalchok. Bid must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting given on above table separately for each package, which shall be valid for 30 days beyond the validity period of the bid i.e. 120 days counted from the bid opening date.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. The number of the partners in the Joint Venture (JV) is limited to three and share of minor partner in the JV shall not be less than 20% while share of the lead partner shall not less than 51%. The bid security of the JV must be in the name of the JV submitting the bid.
- 11. Bidders are advised to visit site and assess the actual site condition before submitting the bid at their own cost.
- 12. MBJCL/MBKHEP reserves the right to accept or reject, wholly or partially any or all the bids without assigning any reason, whatsoever.
- 13. MBJCL/MBKHEP shall not be responsible for any cost or expenses incurred by Bidders in connection with the preparation and submission of bids.
- 14. Any amendment in the Bid notice will be published in the National daily newspaper as well as in the website of MBJCL (www.mbjcl.com.np).
