1. Madhya Bhotekoshi Jalavidyut Company Limited (MBJCL) has allocated funds for Middle Bhotekoshi Hydroelectric Project (MBKHEP) and intends to apply part of the funds to cover eligible payments under the Contract for the followings contracts. Bidding is open to all eligible Nepalese Bidders.
2. **MBJCL/MBKHEP** invites sealed bids from eligible bidders for the construction of two different packages under National Competitive Bidding procedures. Only eligible bidders with the following key qualifications should participate in these bidding:

Bidder shall download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp, Bidders, submitting their bid electronically, should deposit the cost non-refundable fee of **NRS. 5,000.00 (Rupees Five Thousand)** of bidding document in the Project's Rajaswa (revenue) account as specified below separately for each package and the scanned copy (.pdf format) of the Bank deposit voucher shall be uploaded separately for each package by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at Middle Bhotekoshi Hydroelectric Project (MBKHEP), Barhabise Municipality-5, Khorang, Sindhupalchowk at **2:00 PM on Poush 23, 2075**.
6. Electronic bids must be submitted to the office through PPMO website www.bolpatra.gov.np/egpon or before **12:00 hours** on **2075/10/3**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM on Magh 3, 2075** at the office of **Middle Bhotekoshi Hydroelectric Project (MBKHEP), Barhabise Municipality-5, Khorang, Sindhupalchowk**. Bids must be valid for a period of **90 Days** after bid opening and scanned copy of the bid security in .pdf format, amounting given on above table separately for each package, which shall be valid for **30 days** beyond the validity period of the bid i.e. 120 days counted from the Bid opening date.
8. The Number of the Partners in the Joint Venture (JV) is limited to three and share of minor partner in the Joint Venture shall not be less than 20% while share of the lead partner shall not less than 51%. The Bid Security of a JV must be in the name of the Joint Venture submitting the bid.
9. If the last date of submission falls on a government/company holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Bidders are advised to visit site and assess the actual site condition before submitting the bid at their own cost.
11. The Employer (MBJCL) reserves the right to accept or reject, wholly or partially any or all the bids without assigning any reason, whatsoever.
12. MBJCL shall not responsible for any cost or expenses incurred by Bidders in connection with the preparation and submission of Bids.
