- 9. Bids shall be opened in the presence of Bidders' Representatives who choose to attend at **14:00 hrs.** on **2nd June 2013** at the address of Employer's office stated below under number 14. Bids must be valid for a period of 180 days counting from the last date of Bid submission and must be accompanied by Bid Security, amounting to NRs.250,000,000 (Nepalese Rupees Two Hundred and Fifty Million only inclusive of VAT), which shall be valid for minimum 30 days beyond the Bid validity period.
